

The Price Bid under the second cover shall be opened for only those bidders whose technical Applications are responsive to eligibility and qualifications requirements as per Tender document.

EVALUATION OF BIDS/ TENDERS:

1.1 JMF shall evaluate the bids in respect to the substantive responsiveness of the bid or otherwise and shall check the bid to determine whether they are complete, whether any computational errors have been made or required sureties have been furnished.

1.2 Arithmetical error shall be rectified on the following basis: -

a) If there is a discrepancy between the unit price and total price that is obtained multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected by the Employer.

b) In case of discrepancy between words and figures, the amount in words shall prevail.

3. ELIGIBILITY AND QUALIFICATION REQUIREMENTS

The bidders must meet the following minimum qualifying criteria:

- 1.1. That, bidder in the same name & style, should be in business at least for three years at the time of bid opening. In case of change of name of the bidder by merger /acquisitions/change in status, the bidder may be eligible based on the documentary evidence.
- 1.2. That, bidder should have valid registration under various act that may be applicable for the supply/contract proposed. This shall include but not limited to Income tax, Companies Act, Goods & Service Tax (GST), Welfare Cess Act apart from any other applicable tax-imposed time to time by State/Central Govt. and Employee State Insurance, Contract Labour, Provident Fund etc.
- 1.3. That, bidder's financial turn-over in the same name & style during any three years out of last five financial years (FY 2018-19, FY 2019-20, FY 2020-21, FY 2021-22, FY 2022-23) should not be less than Rs. 5.30 Lakh.
- 1.4. The bidder should submit copies of copy of the Income Tax Returns for three previous years for income tax purpose.

1.5. Other requirements:

- 1.5.1. Copy of TDS certificate issued by the client to substantiate the claim for the value of works executed in the private sector OR
- 1.5.2. Copy of form 26AS for the last three financial years.
- 1.5.3. Tender document Fee as requested
- 1.5.4. EMD as requested

4. SCOPE OF WORK: -

- The scope of work includes all required activities for proper completion of work titled as "CIVIL WORK FOR CONSTRUCTION OF 02 MILK BOOTH (STALL) AT DHANBAD RAILWAY STATION "as directed by the Engineer-in-Charge in accordance to the BOQ & Standard Technical Specification of this tender.
- 2. The bidders, at their own responsibility/cost/risk, are advised to visit and examine the site of works and obtain all information that may be necessary for preparing the bid and entering into a contract for execution of the works. It shall be deemed that the bidder has visited the site/ area and got fully acquainted with the working conditions/ other prevalent conditions/ fluctuations and has taken all the factors into account while bidding.
- 3. The work under proposal is to be completed in all respects for the successful completion and handing over the completed works to owner. All safety precautions are required to be taken during the construction period. On award of work, the contractor will carry out the Total stations survey and initial site levels, wherever necessary, as directed by Engineer-in-Charge, JMF.

5. GENERAL TERMS AND CONDITIONS:

- Tenderer should submit their valuable quotation in a sealed envelope super-scribing "CIVIL "WORK FOR CONSTRUCTION OF 02 MILK BOOTH (STALL) AT DHANBAD RAILWAY STATION" on or before 30 Dec 2023 till 03:00 pm at: Medha Dairy Plant, Beside Birsa Munda Central Jail, Hotwar, Ranchi-834012, Jharkhand
- 2. **VALIDITY OF BIDS/ OFFERS**: The Bids /Offers shall remain valid for 120 days from the date of bid opening prescribed by the JMF. A bid valid for a shorter period shall be rejected by JMF as non-responsive.
- 3. Tender submitted shall remain valid for 120 days from the date of opening for the purpose of acceptance and award of work, validity beyond 120 days from the date of opening shall be by mutual consent.
- 4. The Prices shall be quoted in Indian Rupees only.
- 5. The bidders need to furnish details in the prescribed proforma attached
 - a. The interested bidder, shall fill their complete profile in the attached Vendor Registration For men closed as **Annex-A (i), Annex- A (ii) and Annex- A (iii)**
 - b. The Supplier should quote for the job/ items in the prescribed format enclosed as **Annexure-B**.
 - c. The details SOQ is attached as Annexure- C.
- 6. Payment Terms:
 - i. 95% within 30 days on completion of job against Submission of error free original Invoice/Bill duly certified by JMF Authorized personnel.
 - ii. Remaining 5% amount shall be retained as Security Deposit and shall be released after 12 months (Defect Liability Period) *.
- 7. The Time allowed for completion of the work is 30 days and the date of commencement shall be reckoned from the 7th day of issue of Work order awarded.
- 8. Before bidding/tendering, the bidder/tenderer shall inspect the site to get fully acquainted about the site in regard to accessibility of site, nature and extent of ground working condition of site, its locality including stacking of materials, installations of tools and plants (T&P) etc., conditions affecting accommodations and movement of labour etc. for the satisfactory execution of the work contract. No claim whatsoever on such account shall be entertained by Jharkhand State Coop Milk Producers' Federation Ltd in any circumstances.
- 9. No material will be issued by the JMF. Contractor has to arrange & provide all the materials and T&P (Tools & Plants) etc. at his own cost at site.
- 10. Any damage done by the Contractor to the existing structure fittings/fixtures shall have to be made good by the contractor, at his own cost. In failure to do the same, the necessary cost for making the good shall be recovered from the final bill of the contractor.
- 11. Quantities mentioned in the schedule of work may decrease or increase as per the site conditions. Nothing shall be payable for any reduction in scope of work.
- 12. Samples of all the materials required to execute the work shall be approved brand & manufacture and are of best quality. The same shall have to be got approved by the contractor from the JMF Engineer-in-charge before execution of the work.
- 13. All statutory requirement/compliance (Royalty, Labour Law, Mining Challan & Taxes) must be fulfilled by the bidder.
- 14. The contractor shall abide by the rules & regulations of Labour's Laws applicable in their case relating to weekly holidays, overtime allowance, leave with wages and compensatory holidays etc.
- 15. The contractor shall strictly implement all relevant provisions enumerated under Contract Labour (Regulation & Abolition) Act. 1970 and will submit all statutory documents and records

as applicable to concerned authorities and shall take full responsibility for obtaining labour license from Central/State Authority as per the Act. He/she/they will also ensure timely submission of statutory returns as applicable in their case.

- 16. Similar work means construction of residential buildings and office buildings involving finishing items.
- 17. The determination of qualification of a Bidder in evaluation of Technical Bids shall be based upon an examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder and in accordance with the qualification criteria indicated in Qualification and Evaluation Criteria. Factors not included in Qualification and Evaluation Criteria shall not be used in the evaluation of the Bidder's qualification.
- 18. JMF reserves its right to reject the tender on account of unsatisfactory past performance by the present tenderer in another project / sister unit awarded under different enquiry.
- 19. The tenderers are requested to visit the site before quoting for the work.
- 20. The tenderer shall quote rates both in figures and words. He shall also workout the amount for each item of work and writes in both figures and words. On check if there are differences between the rates quoted by the tenderer in words and in figures or in the amount worked out by him, the following procedure shall be followed:
 - i. When there is a difference between the rates in figures and in words, the rates which correspond to the amounts worked out by the tenderer shall be taken as correct.
 - ii. When the amount of an item is not worked out by the tenderer or it does not correspond with the rate written either in figures or in words, the rate quoted by the tenderer in words shall be taken as correct.
 - iii. When the rate quoted by the tenderer in figures and in words tallies but the amount is not worked out correctly the rate quoted by the tenderer shall be taken as correct and not the amount.
- 21. Except writing rates and amount, the tenderer should not write any conditions or make any changes, additions, alterations and modifications in the printed form of tenders. Tenderers who are desirous to offer rebate the same should be brought out separately in the covering letter and submitted along with the tender.
- 22. **Penalty /LD Clause:** If the work by the contractor is delayed beyond the stipulated date of completion, Penalty shall be imposed @ 0.5% of the value of the work awarded for each week of delay, subject to a maximum of 10% of the gross amount of work done.
- 23. The **Defect Liability Period*** shall be of 12 months and shall be start from the actual date of satisfactory completion of the work. Defects pointed out during defect liability period shall be made good by the contractor at his own cost; failure to do the same, the necessary cost for making the good shall be recovered from the amount of security deposit.
- 24. The bidder should pay /deposit Tender document Free (Rs. 1,000/-) and Bid Security (EMD) of Rs 11,000/- along with the technical bid by Demand Draft or through NEFT/RTGS in favour of "THE JHARKHAND STATE COOPERATIVE MILK PRODUCERS' FEDERATION LTD" drawn on any Nationalized Bank and payable at RANCHI. - 26. The Bid is liable to be rejected in case EMD/Tender Fee at prescribed rate is not furnished along with the tender/ bid.
- 27. The tender document fee is Non-Refundable. The bid security (EMD) without interest shall be returned to the unsuccessful bidders after finalisation of contract.
- 28. The EMD deposited by successful agency will be adjusted towards Security deposit as demanded above. If the successful bidder fails to furnish the difference amount between Security Deposit and EMD within 30 (Thirty) days after the issue of Letter of Award of Work, his bid security (EMD) shall be forfeited unless time extension has been granted by "PURCHASER".
- 29. The EMD shall be forfeited if:
 - i. If a bidder withdraws or modifies its bid during the period of bid validity OR
 - ii. If the bidder withdraws its tender before the finalization of tendering process/contract.
 - iii. In the case of the successful bidder, if the bidder fails to sign the Contract (i.e., return the signed copy of duplicate Purchase/Work order, and furnish Performance Security, if asked for)
 - iv. The successful bidder fails to undertake the work or fails to comply with any of the terms and conditions of the contract.
- 30. The Contractor should confirm any ambiguity and discrepancy related to the work and tender in writing before submitting the tender document.
- 31. Amendment of Bidding Document: At any time prior to the deadline for the submission of bids, JMF may modify the bidding document by the issuance of amendment. The amendment will be uploaded on JMF website and will be binding on them. JMF may also at its own discretion, extend the deadline for submission of bids. Before submission of the bid, the bidder should check the JMF website for any Corrigendum/additional information on the bidding document, if any.
- 32. No post-bid clarification at the initiative of the bidder shall be entertained. For evaluation and comparison of bids, the purchaser may, at its discretion, ask the bidder for clarification on the bid. The shortfall information / documents shall be sought only in case of historical documents which pre-existed at the time of tender opening and which have not under gone change since then.
- 33. JMF Reserves the right to reject all or to any of the tenders or to accept the tender or to accept the quotation/ tender either in full or in part or to split of the contract without assigning any reason.
